A. RFP PURPOSE AND SCOPE:

The purpose of this Request for Proposal ("RFP") is to solicit pricing and proposals for the City of Nicholasville, Planning and Zoning from qualified contractors for Debris Removal and Disposal Services for property's located at 450 and 500 Keene Center Drive, Nicholasville, Kentucky 40356.

450 Keene Center Drive

Debris removal, site shall be leveled, seeded and strawed.

B. DESCRIPTION OF SERVICES:

The following description outlines the scope of work for the project.

1. Proposer's will thoroughly examine the specifications, supplemental conditions, and all other documents.
2. Proposer's will make all investigations necessary to thoroughly inform themselves regarding performance of services as required by the RFP Documents. No plea of ignorance as a result of failure to make the necessary examinations and investigations will be accepted as a basis for varying the requirement of the City. If a bidder needs clarification of the RFP documents, bidder must submit a written request to the Purchasing Agent. A request for clarification must be in writing and received by the Purchasing agent, no later than (4) days prior to the scheduled bid opening.

C: SUBMISSION OF RFP:

1. All RFP'S shall be enclosed in sealed envelopes and submitted to the City of Nicholasville, 517 North Main Street, Nicholasville, Kentucky 40356, Attention: Pauline Horsley, Purchasing Agent. The name and address of the proposer, date of the bid opening and the bid name will be shown on the outside of the envelope. **All RFP'S must be received on April 23, 2024 at 12:00 Noon, which at that time will be recorded as being received.**
2. Proposer's agree that the price will remain firm and subject to acceptance by the City for a period Of 60 calendar days from the bid opening date.
3. RFP'S received after the time set for the RFP opening will not be considered.

D: Contractor Experience/References:

1. Each interested Contractor shall have at least (3) three years' experience in the Debris Removal and Disposal Services. Contractor shall provide at least three References.

 4. Contractor must hold a current City of Nicholasville Occupational License.
 5. Business License, contractor shall provide proof of Business License for the City of Nicholasville.
