TERM OF OFFICE, OF THE NICHOLASVILLE CODE OF ORDINANCES. (This ordinance amends Chapter 2, Administration, Article 2, Administration, Article X, Economic Development Authority, Section 2-104. Term of Office, of the Nicholasville Code of Ordinances to add that the City Appointed members shall not be appointed for more than two (2) successive terms.)

Owners to Construct, Repair Sidewalks, Curbs and Gutters, Required for New Construction, of the Nicholasville Code of Ordinances to permit waiver of sidewalks, curbs and gutters by abutting property owners when it is impractical to require same.)

This is to certify that we shall complete all repairs to the asphalt base and complete the 1.5" bituminous surface on or before the end of November, 2011.
