(This ordinance amends Ordinance 853-2012 of the City of Nicholasville Code of Ordinances to exclude from the fireworks definition fireworks defined in KRS 227.702(1), which shall be sold to permanent fireworks retailers. Times for sale of fireworks and who may sell are redefined as well as a change of penalties for violations.)
