The Board of Commission of the City of Nicholasville convened in regular session at 5:00 p.m. on January 28, 2013 at the Nicholasville City Hall. Mayor Russ Meyer presided and the following Commissioners were present: Mr. Andy Williams, Ms. Betty Black, Mr. Pete Sutherland and Mr. Doug Blackford. Also present William M. Arvin, City Attorney.

Motion by Mr. Williams, seconded by Mr. Sutherland to approve minutes as written for the January 14, 2013 regular meeting.

Motion by Ms. Black, seconded by Mr. Sutherland to approve second reading ORDINANCE 858-2013: AN ORDINANCE AMENDING ORDINANCE 843-2012 ESTABLISHING REASONABLE HOURS BETWEEN WHICH FIREWORKS MAY BE USED WITHIN THE CITY OF NICHOLASVILLE AND FORMULATING A PERMITTING PROCESS FOR THE SALE OF FIREWORKS WITHIN THE CITY OF NICHOLASVILLE WHICH SHALL REQUIRE THOSE PERSONS OR ENTITIES ENGAGED IN THE SALE OF FIREWORKS TO BE REGISTERED THROUGH THE CITY TAX OFFICE, APPLY FOR AND BE ISSUED A PERMIT BY THE STATE AND LOCAL FIRE AUTHORITIES, MEET FEDERAL, STATE AND LOCAL SAFETY STANDARDS AND MAINTAIN AT THEIR OWN EXPENSE MINIMAL LEVELS OF LIABILITY INSURANCE. (This ordinance amends Ordinance 853-2012 of the City of Nicholasville Code of Ordinances to exclude from the fireworks definition fireworks defined in KRS 227.702(1), which shall be sold to permanent fireworks retailers. Times for sale of fireworks and who may sell are redefined as well as a change of penalties for violations.)
