

**August 17, 2015  
Special Meeting**

The Board of Commission of the City of Nicholasville convened in special session at 5:00 p.m. on August 17, 2015 at the Nicholasville City Hall. Mayor Pete Sutherland presided and the following Commissioners were present: Mr. Andy Williams, Ms. Betty Black, Ms. Patty Teater and Mr. Doug Blackford. Also present William M. Arvin, City Attorney.

Motion by Mr. Blackford, seconded by Ms. Black to approve the minutes for the August 3, 2015 special called meeting.
