FIRST READING: ORDINANCE 992-2017: AN ORDINANCE AMENDING THE CODE OF ORDINANCES FOR THE CITY OF NICHOLASVILLE, CHAPTER 3, SECTION 3-11 CITY LICENSE, TO AMEND THE FEE FOR CERTAIN CITY LICENSES REQUIRED TO TRAFFIC IN ALCOHOLIC BEVERAGES IN THE CITY. (This ordinance amends the Code of Ordinances of the City of Nicholasville, Chapter 3, Section 3-11, to amend the fee for a distilled spirits and wine special temporary auction license from \$200.00 to \$100.00 per event and to delete the malt beverage brew-on-premises license.)

ORDINANCE 993-2017: AN ORDINANCE AMENDING THE CODE OF ORDINANCES FOR THE CITY OF NICHOLASVILLE, CHAPTER 21, SECTION 21-2 ASSESSMENT OF INTEREST, PENALTY AND COSTS FOR DELINQUENT CITY TAX BILLS. (This ordinance amends the Code of Ordinances of the City of Nicholasville, Chapter 21, Section 21-2, Assessment of interest, penalty and costs for delinquent city tax bills to clarify that all past due city ad valorem tax bills shall accrue interest at the rate of twelve percent (12%) per annum simple interest and that a fraction of a month counts as a full month for purposes of calculating accrued interest.)

ORDINANCE 994-2017: AN ORDINANCE AMENDING THE NICHOLASVILLE SUBDIVISION REGULATIONS, ARTICLE 3 SUBDIVISION PROCESSING, SECTION 332 FEES, SUBSECTION 332.6 CONSTRUCTION PLANS (This ordinance amends Article 3 Subdivision Processing, Section 332 Fees, Subsection 332.6 Construction Plans of the Nicholasville Subdivision Regulations and the Building Permit and Planning and Zoning Fee Schedule in accordance with the recommendation of the Nicholasville Planning Commission to provide that the fee for review of construction plans shall be a \$300.00 initial charge, plus an Engineering Review Fee, which Engineering Review Fee shall be based on \$100.00 per hour for all initial checks and re-checks. The Planning Department will provide a detailed invoice for each project.)

SECOND READING: ORDINANCE 985-2017: AN ORDINANCE ESTABLISHING A DECREE OF ANNEXATION OF APPROXIMATELY 5 ACRES OF LAND, LOCATED ON PARCEL 1 OF THE ROY RHINEHEIMER PROPERTY (PVA #058-00-00-020.00), NICHOLASVILLE, KENTUCKY 40356 contingent on the signing the Memorandum and Agreement. (This ordinance establishes a decree of annexation of the property located on Parcel 1 of the Roy Rhineheimer property (PVA #058-00-00-020.00), Nicholasville, Kentucky 40356, for approximately 5 acres into the City of Nicholasville, Kentucky.)
