The Board of Commission of the City of Nicholasville met in special session on October 2, 2017 at the Nicholasville City Hall, 517 North Main Street at 5:00 p.m.. Motion by Mr. Sutherland, seconded by Ms. Black to approve second reading of Ordinance 991-2017: AN ORDINANCE AMENDING ARTICLE VI OF CHAPTER 21 OF THE CODE OF ORDINANCES, CITY OF NICHOLASVILLE, KENTUCKY, RELATING TO COLLECTION OF TRANSIENT ROOM TAX AND ASSESSMENT OF INTEREST AND PENALTY FOR UNPAID TRANSIENT ROOM TAXES. (This ordinance amends Article VI of Chapter 21 of the Code of Ordinances, City of Nicholasville, Kentucky to impose a transient room tax of three percent (3%) on the rent for every occupancy of a suite, room, or rooms, charged by all persons, companies, corporations, or other like or similar persons, groups, or organizations doing business as motor courts, motels, hotels, inns, "bed & breakfasts," or like or similar accommodations businesses. The ordinance provides that the tax shall be paid fifteen (15) days after the end of each month. The ordinance assesses interest on unpaid transient room taxes in the amount of twelve percent (12%) per annum and provides that violators will be subject to civil and/or criminal action.)
