<small>Excavation and grading, including the digging of a footer shall not be considered construction. However, the pouring of Footer shall be considered construction. Any mobile unit placed in a position on any lot or parcel so as to be ready for occupancy in that location will be considered construction.</small>	
Reissue Permit	\$25.00
<small>There shall be a fee assessed for any alterations or revisions to a previously issued building permit.</small>	
Release for Stop Work Order	\$100.00 per release
Release for Illegal Occupancy	\$200.00 per release
