I further understand that the City of Nicholasville has the right to deny any future requests for a homeowners permit application for electrical work if information is falsified in this document.

I further understand that I must have a rough-in inspection and a final inspection by a Kentucky State Certified Inspector authorized by the City of Nicholasville.

I am and will be doing all the work with my own hands, effort and knowledge, and will perform the work in compliance with required codes and standards in a workmanlike manner and will use approved materials and devices installed in accordance with their manufacturer's instructions. I fully understand that the work must meet the Kentucky Building Code and any and all local building codes. If I am found to have falsified this application in any way, I will face legal action including a fine and/or imprisonment.

Violations of this information will result in permit being canceled. Electrical inspections will not be completed, and Owner and/or Spouse / Domestic Partner will be required to retain the services of a State Licensed Electrician holding a ME and CE License.

No Final Occupancy Inspections on residence will be issued if any of the above statement is found to be false.
